MEMORANDUM OF UNDERSTANDING



This **Memorandum of Understanding** (here in after called as the 'MOU') is entered in to on this date of **20-04-2021 (Twentieth April Two Thousand and Twenty One)**, by and between **Jawaharlal Nehru Technological University Hyderabad College of Engineering, Jagtial, (JNTUHCEJ) Nachupally (Kondagattu), Jagtial Dist.- 505 501, Telangana (India)**, the Higher/ Technical Educational Institution represented here in by its Principal, JNTUH CEJ (here in after referred as '**First Party**', the institution which expression, unless excluded by or offensive to the subject or context shall include its successors-in-office, administrators and assigns).

AND

National Institute of Technology-Warangal (NITW), the Second Party and represented herein by The Director NITW, here in after referred to as "**Second Party**", the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns.

First Party and Second Party are here in after jointly referred to as 'Parties' and individually as 'Party' as

2. In order to facilitate collaborative research work, to establish academic and scientific relationships, to promote joint research activities, to extend mutual support in Postgraduate and Doctoral programme, NITW and JNTUHCEJ, agree to establish this Memorandum of Understanding (MOU).

3. SCOPE OF THE MOU:

The scope of the collaboration in academic and research activities in this MOU include the following categories

- Academic and research collaborations in the mutually interested areas
- Academic interactions and support leading to higher qualifications
- Exchange of academic and scientific information

3.1 Academic and Research Collaborations in the mutually interested areas

- a) Faculty from NITW and JNTUHCEJ can engage in collaborative research work, support and help each other in carrying research projects.
- b) Joint project proposals can be developed by the faculty members from NITW and JNTUHCEJ to submit to funding agencies such as DST, DBT, UGC, AICTE, NRB, DRDO, etc.,

- c) Any intellectual property rights (IPR) in connection with the joint projects shall belong to both the institutions.
- d) The visible output in the form of conference proceedings, journal publications and book chapters which resulted from the collaborative research work, joint projects and research work that leads to Ph.D. degree, shall belong to the faculty members and credentials shall be given to them who involved and executed the work as per the research and publishing ethics.

3.2 Academic Interactions and Support Leading to Higher qualifications:

- a) NITW shall give opportunity to faculty members of JNTUHCEJ to register for Ph.D., on part-time/external mode subject to their meeting the admission criteria and based on interview performance.
- b) The faculty can complete the required courses by self-study and can appear for the examinations. JNTUHCEJ shall grant permission to the faculty members who register Ph.D., at NITW to write those examinations.
- c) If a faculty member of JNTUHCEJ registers for Ph.D. degree at NITW, he shall have one guide at JNTUHCEJ and one guide at NITW.
- d) A faculty member at JNTUHCEJ who is eligible to guide Ph.D. scholars can act as internal guide.
- e) If guide is not available in the parent department from JNTUHCEJ or NITW in the proposed research area, eligible faculty who belongs to allied departments can act as one of the guides. However, in such cases, one guide must be from the parent department either at JNTUHCEJ or NITW.
- f) The remaining Ph.D. guidelines, rules and regulations as per the NITW shall be followed.
- g) The instruments, equipment and other research facilities at NITW can be utilized by the faculty members for their Ph.D. work as per institute norms with applicable fee.

3.3 Exchange of Academic and Scientific Information:

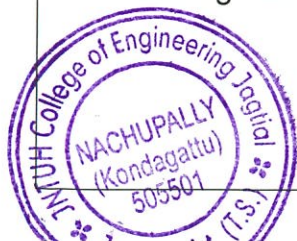
- a) NITW and JNTUHCEJ can support and help each other in the academic programmes by conducting joint workshop, conferences, seminars, by arranging short visits, guest lectures and training programmes for the faculty members and students.
- b) Faculty shall share articles, publications, scientific information, patents information etc., for their academic needs and not for commercial purposes on mutual consent and case to case basis with regard to revenue sharing and expenditure.

4. Financial Commitment

The first party shall reimburse the expenses incurred and pay for the services rendered by the second party towards activities covered under this MoU.

5. Validity and Maturity

This Agreement will be valid for a period of five years. This MoU may be terminated by either of the parties forthwith if any other party commits breach of any of the terms hereof and shall have failed to rectify such breach within **60** days of the notice in this behalf having been served on it by the other party.
